

### **About Star Ratings**

# The Centers for Medicare & Medicaid Services (CMS) Star Ratings for SNFs:

Quality of Resident Care, Health Inspections, and Staffing each contribute to an Overall Star Rating also assigned by CMS. The above-listed CMS Quality of Resident Care Star Ratings are assigned based on a select set of clinical data measures and make up one part of the Overall Star Rating. CMS star ratings are assigned by CMS to help consumers, their families, and caregivers compare facilities and agencies more easily. Star ratings are subject to change on a regular basis. CMS recommends using star ratings together with other sources of information to determine whether a nursing home fits your or your family members' needs.

#### **CMS Star Ratings for Home Health Agencies:**

CMS Home Health Compare uses a star rating between 1 and 5 to show how a home health agency compares to others on measurements of their performance. The star ratings are based on 8 quality measures that give a general overview of performance. Ratings are calculated from rehospitalization claims data, OASIS collection data, and patient survey results. Visit medicare.gov/homehealthcompare for the most up-to-date star ratings.

# Medicare Benefits for Skilled Nursing Facility Care

Medicare Part A (Hospital Insurance) covers skilled nursing facility care for a limited time (on a short-term basis) if all these conditions apply:

- You have Part A and have days left in your benefit period to use.
- You have a qualifying inpatient hospital stay.
- Your doctor has decided that you need daily skilled care (like intravenous fluids/medications or physical therapy). You must get the care from, or under the supervision of, skilled nursing or therapy staff.
- You get these skilled services in Medicare-certified SNF.
- You need these skilled services for a medical condition that's either:
  - A hospital-related medical condition.
  - A condition that started while you were getting care in the SNF for a hospital-related medical condition.

#### **Your Costs in Original Medicare**

In each benefit period, you pay:

- Days 1 20: \$0 copayment (Note: If you're in a Medicare Advantage Plan, you may be charged copayments during the first 20 days)
- Days 21 100: \$204 coinsurance per day
- · After day 100: All costs

Part A limits SNF coverage to 100 days in each benefit period.

Note: Your doctor or other health care provider may recommend you get services more often than Medicare covers. Or, they may recommend services that Medicare doesn't cover. If this happens, you may have to pay some or all of the costs. Ask questions so you understand why your doctor is recommending certain services and if, or how much, Medicare will pay for them.

#### A Note for Patients with Medicare Advantage

Medicare Advantage and other Managed Care members will need to qualify and be approved for this benefit by your Managed Care payer. Your Managed Care network and coverage can impact facility choice or availability.
